

Privacy Policy

Disclosure of information

All Survivors Project (ASP) will not share, sell, or otherwise disclose your personal information to any third party unrelated to ASP, other than where the law requires or where we have sought and been given your specific consent to do so.

What information we collect and how we use it

ASP collects and retains information you voluntarily submit to us through our newsletter subscription form and by contacting us via email. In the future, we may request personal data in forms not mentioned here, such as when you donate, volunteer, register for an ASP event, make an inquiry, visit our website, or apply for employment.

If you subscribe to our newsletter, we collect your email address, your name, and other personal data. Mailchimp, the third-party software we use to manage our e-mail lists, may gather other data, which is governed by their own data protection policies. If you wish to unsubscribe from our newsletter, you may do so by clicking “unsubscribe” in any edition that you have received.

We may also use your data to offer services, effectively operate our website (via use of cookies), manage your inquiries, subscriptions, donations and other interactions with you.

If you submit personal information when contacting us, it will be read by a staff member and may be shared with other members of our staff. It will be retained for 12 months unless you request us to delete it.

Use of cookies

ASP uses cookies (small text files) that our site may place on your computer as a tool to remember your preferences. You may refuse the use of cookies by selecting the appropriate settings on your browser. Some cookies on this site are essential, and the site will not work as expected without them. These cookies are set when you submit a form, login or interact with the site by doing something that goes beyond clicking on a link. We also use some non-essential cookies to anonymously track visitors or enhance your experience of this site, including through Google Analytics.
